12. The remaining Trustees are also decided to amend the main objects of the Trust as per the income Tax Act, to get the registration under section 80G of the Income Tax Act. The changes in the main objects are as follows

To establish, run, maintain, develop, improve, extend, grant, donate for and to aid and assist in the establishment, running, maintenances and extension of Institutions, providing, general, commercial or Technical Educations or Elementary schools, Secondary Schools High Schools, Colleges and other art, craft, and science schools, Hostels for the benefit of students and generally all kinds of Educational Institutions for the welfare and uplift of the General Public.



